4. The **Advanced Search** menu can be expanded or collapsed, allowing you to further refine your search

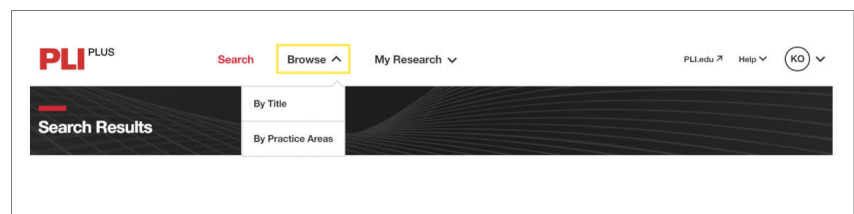

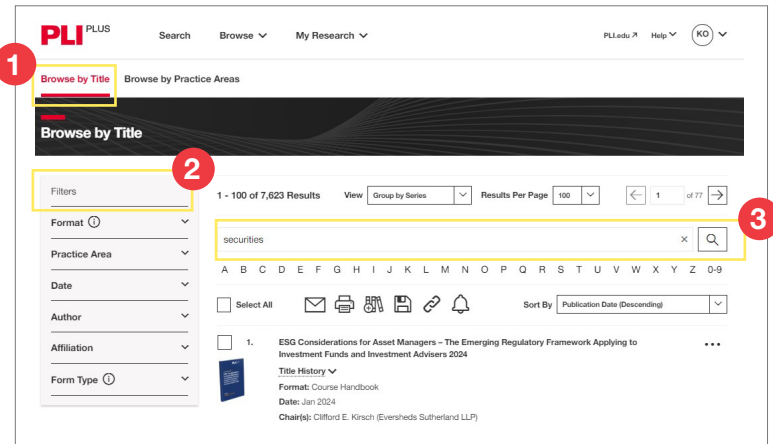

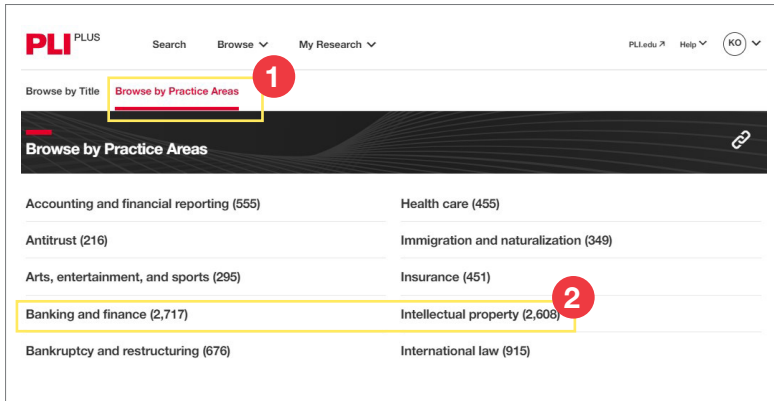
# Browse by Title

3. If you know the name of the title you're seeking, you can enter it in the **Jump to title** field

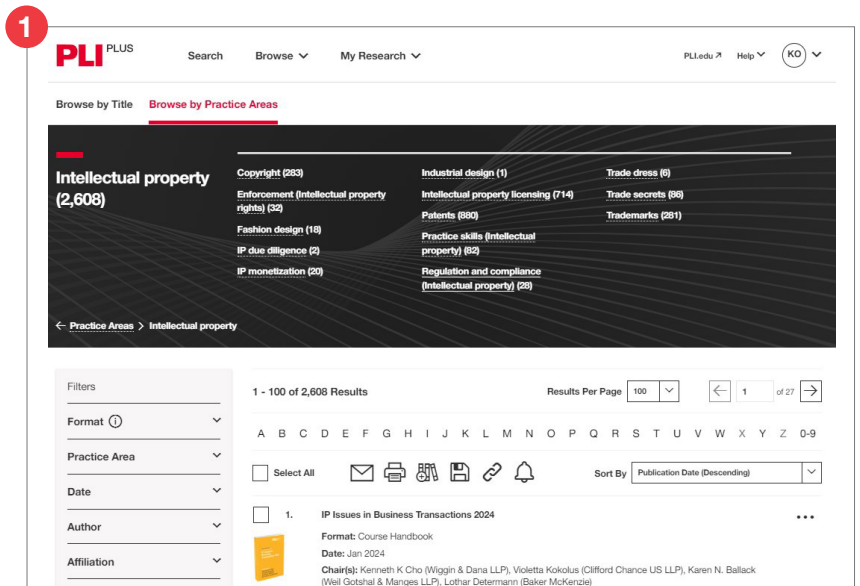
